# **Privacy Policy**

# In this privacy policy, the Stichting Bescherming Privacybelangen (SBP) / the Privacy Protection Foundation explains how we treat your personal data.

#### What does SBP do?

SBP is an organization that represents the interests of people who have been aggrieved by Google's privacy invasions. The SBP was founded with the statutory duties to protect privacy interests against any unlawful infringement and obtain redress for such violations.

### Does SBP process personal data for that purpose?

SBP processes personal data only when strictly necessary to execute our statutory duties. For example, SBP would process personal data if there were legal proceedings concerning a data breach. SBP also uses personal data to inform you about our legal proceedings.

# What kind of personal data does SBP process?

The data that SBP collects and uses is processed by us, typically because you have contacted SBP and, in doing so, have released information about yourself. This occurs, for example, when you choose to sign on with us as an Aggrieved Party.

#### On what legal basis is SBP allowed to process my personal data?

SBP is only allowed to use your personal data for reasons that are listed in the relevant privacy legislation.

SBP processes your personal data to execute the agreement between you and SBP. SBP also processes data for our legitimate interest to execute our statutory duties (article 6, para. 1, sub f, GDPR).

If you consent to the processing of your personal data—for example when you subscribe to our newsletter—that consent is used as a processing ground for the relevant purpose (article 6, para. 1, sub a, GDPR).

#### Does SBP share my personal data with third parties?

SBP may share your data with the parties representing and otherwise assisting SBP in connection with fulfilling SBP's statutory duties. SBP does not share your data with any third party that is not operating under a duty of confidentiality.

#### **Data retention**

SBP does not keep your personal data longer than strictly necessary. It is possible that SBP has to keep your data for a longer period of time based on legal obligations prescribed by national law.

### **Security measures**

SBP has implemented necessary technical and organizational measures to protect the personal data that SBP processes. For example, these measures ensure that your data will not get lost. The safeguarding of your personal data takes places in compliance with relevant regulations and guidelines.

An example of an organizational measure is that within SBP, only competent SBP staff members have access to your personal data. These staff only have access insofar as necessary to fulfil their duties.

# What are my rights surrounding my personal data?

SBP processes your personal data for the purposes described above. Considering the data that SBP processes you have several rights you may exercise by sending us a request. The following list describes the types of requests you may file with us:

- **Right of access:** If you file a request for the right of access, you will receive a specified overview of the personal data that SBP processes.
- **Right to rectification:** If you file a request to rectify inaccurate personal data, SBP will correct that data. If necessary, SBP will correct its data by providing a supplementary statement.
- **Right of erasure:** You may request that SBP erase your personal data.
- **Right to restriction of processing:** In some cases, you may file a request with SBP to restrict the processing of your personal data.
- **Right to object:** Depending on your particular situation, you may object to the processing of your personal data by SBP.
